1. Introduction

Investing in the care economy is crucial to achieving gender equality, decent work, and economic growth as laid out in the 2030 Agenda for Sustainable Development and the Sustainable Development Goals (SDGs), particularly SDGs 5 and 8. The COVID-19 pandemic underscored the critical role of care systems in sustaining societies and economies. It highlighted vulnerabilities and inequalities in existing care systems, including the undervaluation of care work, the lack of investment in care infrastructure, and the disproportionate burden placed on women, particularly in unpaid care. It revealed the precarious working conditions and risks faced by paid care workers, such as low wages and insufficient social protection.

In response, countries across Asia and the Pacific have increasingly recognized the imperative of investment in the care economy as a vital component of their development strategies. Governments, civil society, private sector, development partners as well as other stakeholders in Asia Pacific are taking increasingly coordinated action to address this challenge. Care work, though undervalued, contributes significantly to national economies as well as societal functioning and wellbeing. Women's contribution to all types of care work is estimated to contribute a massive <u>USD 11 trillion to the global economy annually</u>. The demand for paid care services – including childcare, care for vulnerable populations (e.g. older persons and persons with disabilities), and healthcare— is growing due to demographic shifts, such as large and growing ageing populations.

Care work is a major driver of migration in and from Asia and the Pacific, in particular of women migrant workers. Estimates suggest that a quarter of all care workers globally are domestic workers. A survey of ASEAN countries of destination found almost all domestic workers (99 per cent) are doing indirect care work, with 62 per cent doing direct care work.

Globally and in Asia-Pacific, women take on a disproportionate burden of unpaid care work. This is exacerbated by a lack of services which, combined with social norms ascribing caregiving roles to women, results in women using their time, energy, and resources to fill the gaps. This creates a powerful, persistent barrier to women's ability to participate in the labour market, reduces their leverage and options for decent work, and impedes their economic empowerment.

A variety of accessible, affordable, quality care services is crucial to free up women's time, encourage their participation in the labour market and improve overall societal well-being by ensuring that vulnerable groups, such as children, older persons, persons with disabilities, and the poor receive the care they need. It is crucial that states, civil society, the private sector and communities share the responsibility of reimagining care as a public good and a right that benefits all members of society. Investing in the care economy and advancing the rights of care workers to have decent work opportunities in the paid care sector is crucial to transform care systems. The 5R Framework for Decent Care recognizes the critical role

of paid and unpaid care work and seeks to promote decent conditions for care workers whilst ensuring decent services.²

The **2024 Asia-Pacific Care Champions event,** convened at the Asia-Pacific Ministerial Conference on the Beijing+30 Review, will honour and celebrate trailblazers who have made pioneering contributions to building inclusive and sustainable care systems. These champions are at the forefront of driving transformative change, setting examples of best practices, and inspiring others to take bold actions that contribute to the broader goals of the 2030 Agenda for Sustainable Development. By recognizing these champions, the event aims to galvanize further action, encourage the scaling up of successful initiatives, and foster a collaborative environment where a diverse range of stakeholders can work together to create resilient and equitable care systems.³

This special event will be hosted by the United Nations Economic and Social Commission for Asia and the Pacific (ESCAP) and UN Women, with the support of the Global Alliance for Care and in collaboration with Oxfam and the World Bank.

2. Objectives

The event to celebrate the 2024 Asia-Pacific Care Champions will provide a platform for showcasing excellence, sharing innovation and good practices, and reinforcing the commitment of all stakeholders to building robust and equitable care systems across Asia and the Pacific. Specifically, the event aims to:

- Recognize Contributions: Acknowledging and celebrating the efforts of governments, civil society
 organizations, private sector, academia, and other relevant stakeholders including Global Alliance
 for Care members in advancing inclusive care policies through multistakeholder approaches
- **Showcase Innovation:** Highlighting innovative policies and practices that can serve as inspiration for replication and scale up across the Asia-Pacific region
- **Foster Collaboration:** Strengthening partnerships between governments, civil society, the private sector, international organizations and other diverse stakeholders towards an increasingly 'caring future'
- Launch Key Resources: Introducing new policy tools and briefs that can support policy development and on-the-ground initiatives
- **Inspire Action:** Encouraging others to draw from these examples and take bold steps that will drive the transformation of care systems across the region.

Celebrating Champions that Care

Recognizing and honouring initiatives that have made outstanding contributions to the care economy, in the following categories:

Reward care workers with improved conditions and remuneration, ensuring they have access to social protection and labour rights. Represent care workers and recipients in decision-making processes, including through collective representation, organization, and processes of social dialogue and collective bargaining.

This category acknowledges strategic alliances across sectors—governments, civil society, international organizations, and private entities that have harnessed the collective strength of multistakeholder efforts to push forward a caring and inclusive future.

The recognition of Care Champions will further elevate the region's commitment to advancing the care economy and influencing global discourse on care policies, positioning all participants as *shareholders* of our common, caring future.

The 2024 Asia-Pacific Care Champions are expected to lead transformative change going forward, with an emphasis on:

- Advocacy: Raising awareness about the critical role of care systems in achieving social and economic goals, including the 2030 Agenda for Sustainable Development
- **Collaboration**: Fostering partnerships that strengthen care policies and sharing good practices and lessons learned
- **Innovation**: Promoting innovative approaches to care that can be scaled up and adapted to contexts across the Asia-Pacific region.

4. Background

ESCAP will convene the Asia-Pacific Ministerial Conference on the Beijing+30 Review in collaboration with UN Women Regional Office for Asia and the Pacific, in Bangkok, from 19-21 November 2024. The Conference will bring together Ministers, senior officials and representatives from relevant Ministries, civil society organizations, youth organizations, academia, the private sector, UN entities, independent experts and other key stakeholders from across the Asia-Pacific region to:

- Assess progress on the implementation of the Beijing Declaration and Platform for Action (BPfA) in Asia and the Pacific over the past five years;
- Review current and emerging challenges, good practices, lessons learned, and priority actions required to achieve gender equality and the empowerment of women and its contribution towards the full realization of the 2030 Agenda for Sustainable Development;
- Provide a platform for member States and stakeholders to explore policy options and strategies, including innovative approaches, toward realizing gender equality and the empowerment of women;
- Build regional consensus on priority actions to accelerate the implementation of commitments made in the BPfA, and;
- Consolidate regional inputs to the sixty-ninth session of the Commission on the Status of Women which will focus on the review and appraisal of the implementation of the Beijing Declaration and Platform for Action and the outcomes of the 23rd special session of the General Assembly.

2025 will mark the thirtieth anniversary of the Fourth World Conference on Women and adoption of the Beijing Declaration and Platform for Action (1995). It is critical to re-envision care systems to empower women and create inclusive and caring societies and economies that benefit everyone, including the most vulnerable and to 'leave no one behind'. As the global community rethinks how to accelerate our progress to achieve gender equality and women's economic empowerment and the wider SDGs through the upcoming 69th Commission on the Status of Women in March 2025, the Care Economy Special Event provides a timely opportunity to reflect on the critical importance of transforming the care economy.
